I. SUBMISSION

1. Pursuant to Trial Chamber V's ("Chamber") 7 December 2021 Decision,¹ the Office of the Prosecutor ("Prosecution") hereby provides its updated list of evidence ("LoE").²

2. The LoE includes 120 additional items to the Prosecution's 9 November 2020 LoE, as authorised by the Chamber ("120 Items").³ As of this filing, the total number of items on the LoE stands at 19,962. Note that the 120 Items do not include material deemed formally submitted by the Chamber pursuant to rule 68(3) as 'associated exhibits', but which were not included in the Prosecution's original LoE.⁴

3. The 120 Items are identified by Evidence Registration Number ("ERN") under the column "authorised ERNs" in confidential Annex B.⁵ Confidential Annex B also identifies the Prosecution's requests and the Chamber's decisions authorising the inclusion of these items in the LoE.
