I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 26 August 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Pre-Trial INCRIM package 086” containing 1 item, “Pre-Trial INCRIM package 087” containing 1 item, “Pre-Trial Other package 015” containing 179 items and “Pre-Trial Other package 016” containing 41 items.

4. The disclosure of “Pre-Trial INCRIM package 086” consists of an English translation of a disclosed witness statement.¹

5. The disclosure of “Pre-Trial INCRIM package 087” consists of the re-disclosure of an item previously disclosed, now with lesser redactions.

6. The disclosure of “Pre-Trial Other package 015 and 016” consists of documents related to witnesses P-0314, P- 0359, P-0434, P-0459, P-0460, P-0485, P-0505, P-0519, P-0520, P-0589, P-0980, P-1416, P-1584, P-1647, P-1839 and P-2138. The Prosecution provides these items for the sake of completeness as part of its ongoing review of the

evidence and under the legal classification of “Other” as they do not obviously include information material to the preparation of the Defence under rule 77 of the Rules of Procedure and Evidence.
