I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 21 October 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 091” containing 3 items, “Trial reclassification to INCRIM package 009” containing 1 item, and “Trial Rule 77 package 061” containing 28 items.

4. The disclosure of “Trial INCRIM package 091” consists of the re-disclosure of lesser redacted versions of one statement related to P-0885, one investigation report related to P-2105 and one annex related to P-2105 supplementary witness statement.

5. The disclosure of “Trial reclassification to INCRIM package 009” consists of the re-disclosure of lesser redacted version of one translation being reclassified as INCRIM and related to P-0885.

6. The disclosure of “Trial Rule 77 package 061” consists of items that are deemed material to the preparation of the Defence. It contains Call Data Reports and associated material of 13 trial witnesses P-0491, P-0881, P-0975, P-0100, P-0882, P-0119, P-1563, P-3053, P-1524, P-1424, P-1967, P-0342, and P-1339; two items re-disclosed with lesser

redactions relevant to P-2069, and one item relevant to P-2105, a medical certificate mentioned in his witness statement.
