I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 7 December 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani "Trial INCRIM package 107" containing 8 items, "Trial Rule 77 package 074" containing 6 items and "Trial Image Update package 004" containing 1 item. On 8 December 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani "Trial Rule 77 package 075" containing 5 items.

4. The disclosure of "Trial INCRIM package 107" consists of documents related to witnesses P-2607, P-2692 and P-0435. This package includes documents that are being disclosed with lesser redactions, P-2692 witness preparation log and Annex A as well as the English translation of P-0435's second statement. The disclosure of "Trial Rule 77 package 074" consists of a document related to witness P-2692 and the unredacted Call data reports and Call Sequence tables of witnesses P-2172 and P-1420.

5. The disclosure of "Trial Image package 004" consists of a document that is being re-disclosed with a corrigenda note correcting an ERN typo.

6. The disclosure of "Trial Rule 77 package 075" consists of an investigation report related to P-2607 and the unredacted CDR reports and CST annexes of P-2295 and P-3047.
