I. Introduction

1. After the submission of the “Report on the Registry’s consultations with States on the Interim Release of Mr Mokom and Request for Guidance”,¹ the Registry received responses from seven more States to which the Registry had communicated notes verbales requesting them to consider accepting Mr Maxime Geoffroy Mokom Gawaka’s (“Mr Mokom”) interim release in their respective territories.

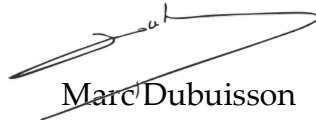
