Subject Objet	Administrative Decision amending the Roster within the Meaning of regulation 46(3) of the Regulations of the Court		

1. **THE PRESIDENT OF THE PRE-TRIAL DIVISION** of the International Criminal Court hereby issues this administrative decision amending the roster within the meaning of regulation 46(3) of the Regulations of the Court (the ‘Roster’ and the ‘Regulations’) pursuant to the authority vested in him to oversee the administration of the Pre-Trial Division as set forth in regulation 14 of the Regulations.

2. On 15 October 2019, the then President of the Pre-Trial Division issued the ‘Administrative Decision amending the Roster within the Meaning of regulation 46(3) of the Regulations of the Court’ (the ‘15 October 2019 Decision’).¹

3. On 16 March 2021, the Presidency of the Court adopted the ‘Decision assigning judges to divisions and recomposing Chambers’ (the ‘16 March 2021 Decision’).²

4. On 24 March 2021, Judge Rosario Salvatore Aitala was elected as President of the Pre-Trial Division.

5. The President of the Pre-Trial Division notes that the Roster has not been amended following the expiry of the Roster adopted by means of the 15 October 2019 Decision and that the Chambers of the Pre-Trial Division have been recomposed by means of the 16 March 2021 Decision.

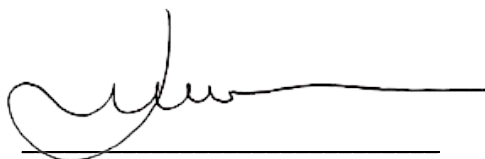
6. Accordingly, as set out in the annex to the present decision, the President of the Pre-Trial Division hereby amends the Roster with retroactive effect from the date of the expiry of the Roster adopted by means of the 15 October 2019 Decision. Since the mandate of Pre-Trial Chamber A is limited to offences under article 70 of the Rome Statute, this Roster is limited to Pre-Trial Chamber I and Pre-Trial Chamber II.

7. While the present decision shall be made available publicly, the Roster itself shall not be communicated to the Registry, the Prosecutor and the general public.

**FOR THESE REASONS, THE PRESIDENT OF THE PRE-TRIAL DIVISION
HEREBY**

AMENDS the roster within the meaning of regulation 46(3) of the Regulations in accordance with the annex to the present decision.
