I. NOTIFICATION

1. Pursuant to Pre-Trial Chamber II's ("Chamber") 12 April 2023 "Decision on the Prosecution's requests to vary a time limit and/or for reconsideration (ICC-01/14-01/22-180) and to amend its witness table (ICC-01/14-01/22-184)",¹ the Prosecution submits this Communication Report regarding the amendments to disclosure metadata.

II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified as "Confidential" as it relates to evidence disclosed *inter partes* that should not be released to the public.

III. DISCLOSURE OF EVIDENCE

3. On 19 April 2023, the Prosecution amended the disclosure metadata of the evidence disclosed to the Defence of Maxime MOKOM in (i) Pre-Confirmation Metadata Update package 005 containing 39 items, as authorised by the Chamber;² (ii) Pre-Confirmation Reclassification to INCRIM package 003 containing 13 items, as authorised by the Chamber;³ (iii) Pre-Confirmation Metadata Update package 006 containing 233 items, as per the *inter partes* Mokom Defence Team's Request dated 17 April 2023. These items are listed in the Confidential Annex.
