I. NOTIFICATION

1. Pursuant to Pre-Trial Chamber II's ("Chamber") 27 June 2022 "Order on the conduct of the confirmation of charges proceedings",¹ clarified in the Chamber's subsequent decisions issued on 24 January 2023² and 2 February 2023,³ the Prosecution submits this Communication Report regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified as "Confidential" as it relates to evidence disclosed *inter partes* that should not be released to the public.

III. DISCLOSURE OF EVIDENCE

3. On 19 May 2023, the Prosecution amended the disclosure metadata of the evidence disclosed to the Defence of Maxime MOKOM in Pre-Confirmation Metadata Update package 007 containing 415 items, as per the Mokom Defence's "Request to Rectify Deficiencies in Disclosure Metadata", dated 15 May 2023.⁴ These items are listed in the Confidential Annex.

4. The updated metadata concerns the "related to witness" category which has been added to items in line with the E-Court Protocol. For 26 items the value in the "related to witness" category was removed as the affected items had previously been

classified by mistake to relate to a witness.⁵
