I. NOTIFICATION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

CONFIDENTIALITY

2. The filing and its annex are classified as "Confidential" as they relate to *inter partes* communications, which cannot be made public at this stage.

II. DISCLOSURE OF EVIDENCE

3. Following Trial Chamber V's decision in the *Yekatom and Ngaïssona* case¹, the Prosecution has reviewed the Yekatom Defence materials used and/or formally submitted through overlapping Prosecution witnesses between the *Mokom* and *Yekatom and Ngaïssona* cases.
4. On 19 July, the Yekatom Defence team agreed to a list of Yekatom Defence items² identified by the Prosecution team.
5. On 21 July 2023, the Prosecution disclosed to the Defence of Maxime Mokom "Pre-confirmation Rule 77 Package 025" containing 92 items. The Prosecution has indicated in the "ICC-01/14-01/22 - Disclosure Notes" field which witnesses the items were used with.
