I. NOTIFICATION

1. Pursuant to Trial Chamber V's Decision in the *Yekatom and Ngaïssona* case¹ The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The filing and its annexes are classified as "Confidential" as they relate to Prosecution witnesses and evidence that cannot be made public at this time.

III. DISCLOSURE OF EVIDENCE

3. On 11 August 2023, the Prosecution disclosed to the Defence of Maxime Mokom "Pre-confirmation INCRIM Package 020" containing 38 items.² The package contains 31 photographs and 7 other documents (a press article, a list and cover pages to open source reports) used or formally submitted through witness P-1576 in the *Yekatom and Ngaïssona* case. The witness's interview is relied upon for the purposes of the confirmation hearing and therefore these items, which are the ones also used with the witness by the Prosecution in the *Yekatom and Ngaïssona* case, are disclosed under the classification of INCRIM for consistency. None of the items disclosed will however be used for the purposes of the confirmation hearing.

4. On 11 August 2023, the Prosecution disclosed to the Defence of Maxime Mokom "Pre-confirmation Rule 77 Package 032" containing 18 items.³ All items are
