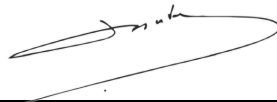

I. Transmission

1. The Registry hereby transmits the letter to Pre-Trial Chamber II ("Chamber"), addressed to the Registrar communicated by the authorities of the Central African Republic ("CAR") to the Registry on 23 November 2023 to seek the cooperation of the Prosecutor of the International Criminal Court "pour l'exécution du mandat d'arrêt contre Maxime Jeoffroy Eli Mokom Gawaka, afin d'obtenir son extradition vers la République Centrafricaine, pour qu'il exécute la peine prononcée contre lui".¹

II. Classification
