I. SUBMISSIONS

1. Pursuant to Trial Chamber V's ("Chamber") 6 April decision¹ and 5 June decision² on the Prosecution's requests for the formal submission of prior recorded testimonies, the Prosecution annexes the accompanying declarations regarding P-0595, P-1773, P-1865, P-2416, P-2472, and P-2652, pursuant to Rule 68(2)(b)(ii) and (iii) of the rules of Procedure and Evidence, as follows:³

- P-0595: Certification effectuated in Cameroon (Annex A);⁴
- P-1773: Certification effectuated in Cameroon (Annex B);⁵
- P-2416: Certification effectuated in Cameroon (Annex C);⁶
- P-1865: Certification effectuated in CAR (Annex D);⁷
- P-2652: Certification effectuated in CAR (Annex E);⁸
- P-2472: Certification effectuated in Nigeria (Annex F).⁹

2. While P-0595, P-1773, P-2416, P-1865 and P-2652 made corrections to their prior recorded testimonies,¹⁰ none of these corrections are substantial or would affect their submission per Rule 68(2)(b).
