I. NOTIFICATION

1. Pursuant to Pre-Trial Chamber II's ("Chamber") order,¹ and for the benefit of the parties and participants, the Office of the Prosecutor ("Prosecution") submits its updated list of evidence.

III. SUBMISSION

3. On 24 August 2023, the Prosecution informed² the Chamber and the Defence of Maxime Mokom, of the inadvertent disclosure of item CAR-OTP-00000399, which contained sensitive and confidential information [REDACTED].

4. Upon the Chamber's request, the Prosecution provided reasons in support of its request.³ On 25 August 2023, the Chamber ordered the Prosecution to file a revised List of Evidence excluding the item in question.⁴
