I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 26 January 2024, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani "Trial INCRIM package 124" containing 10 items and "Trial Rule 77 package 093" containing 12 items.

4. Trial INCRIM package 124 consists of lesser redacted versions of Witness P-1808's and P-2519's statements, a screening note related to P-1808, Investigation reports related to P-2241 and P-1289 as well as the log and annexes relevant to the witness preparation sessions of P-1289 and P-0662 .

5. Trial Rule 77 package 093 consists of identifying documents related to witness P-2519, Investigation Reports related to Witnesses P-1289, P-1808, P-2519, victim participation application forms as well as the call data records of Witnesses P-1432, P-2239 and P-2337.
