I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as it relates to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 4 July 2024, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani the following packages "Trial INCRIM package 147" containing seven items, "Trial Rule 77 package 114" containing five items and "Trial Metadata Update package 017" containing one item.

4. On 5 July 2024, the Prosecution then disclosed "Trial INCRIM package 148" containing six items and "Trial Rule 77 package 115" containing one item.

5. Trial INCRIM package 147 consists of lesser redacted versions of the statements of Witnesses P-1264, P-2573 and related annexes and a screening note related to P-2573.

6. Trial INCRIM package 148 consists of Witness P-2573's witness preparation log and related annex as well as photographs related to his statement.

7. Trial Rule 77 package 114 consists of the transcript and translation of a video, Witness P-0349's witness preparation log, related annex and investigation report.

8. Trial Rule 77 package 115 consists of an investigation report related to Witness P-2573.

9. Trial Metadata Update package 017 consists of the lesser redacted version of the statement of Witnesses P-1264.
