I. Introduction

1. The Registry hereby informs Trial Chamber VI (“Chamber”) of the appointment of Mr Arpad (Julius) von Bóné (“Mr von Bóné”) as Legal Adviser to Witness P-0349 (“Notification of Appointment”), pursuant to rule 74 of the Rules of Procedure and Evidence (“Rules”).

II. Classification

2. Pursuant to regulation 23 *bis*(1) of the Regulations of the Court (“RoC”), the annexes to the present submission are classified as confidential, as they contain personal information and contact details of Mr von Bóné.

III. Applicable Law

3. The Registry has considered the following provisions: article 68 of the Rome Statute, rules 21 and 74 of the Rules, regulations 67 and 69 of the RoC, regulation 123(1) of the Regulations of the Registry, and articles 5, 8 and 22(3) of the Code of Professional Conduct for counsel (“Code”).

IV. Submissions

4. On 10 July 2024, the Registrar appointed Mr von Bóné as Legal Adviser to Witness P-0349.¹ Mr von Bóné will be duly provided with access to the relevant material in connection with the case, including the statements and transcripts of interviews of Witness P-0349, *via* a secure channel in order to maintain confidentiality at all times.

5. On 6 March 2015, Mr von Bóné executed the solemn undertakings required by articles 5 and 22(3) of the Code.²
