I. INTRODUCTION

1. In accordance with rule 13(1) of the Rules of Procedure and Evidence, the Registry hereby transmits to Pre-Trial Chamber I ("Chamber"), a request, received on 11 July 2024, from the State of Israel, for access to certain documents filed in the record of the Situation in the State of Palestine .

II. PROCEDURAL HISTORY

2. On 11 July 2024, the Registry received an e-mail from Ms Avigail Frisch Ben Avraham, with a document attached thereto, entitled "*Request for Access to the Application for Arrest Warrants for Benjamin Netanyahu and Yoav Gallant*", together with two annexes ("Documents").¹
3. In the context of a similar request, and upon the Registry's request for guidance, on 1 July 2024, the Chamber provided the Registry with directions as to how to process this type of documents.²
4. Accordingly, the Chamber instructed the Registry to ("Instructions"):
 - submit the Documents in the record of the Situation *via* a Registry's transmission filing;
 - file the transmission filing and the attached document on a Secret basis³ and;

- annex the Documents to the transmission filing.
5. On 11 July 2024, following a request for clarification from the Registry, the Chamber confirmed its previous Instructions.⁴
