I. INTRODUCTION

1. Pursuant to Trial Chamber V's ('Chamber') "Decision on the Fourth Ngaïssona Defence Request for Leave to Add Items to its List of Evidence",¹ the Defence for Mr Patrice-Édouard Ngaïssona ('Defence') hereby provides in Annex A to this filing its updated List of Evidence ('Second Updated List').
2.
