I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as it relates to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. Between 9 July and 19 July 2024, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani the following packages. On 9 July 2024, "Trial INCRIM package 149" containing one item; on 10 July 2024, "Trial INCRIM package 150" containing eight items and "Trial Rule 77 package 116" containing fifteen items; on 11 July 2024, "Trial INCRIM package 151" containing one item; on 16 July 2024, "Trial INCRIM package 152" containing four items and "Trial Rule 77 package 117" containing four items; on 17 July 2024, "Trial INCRIM package 153" containing three items, "Trial INCRIM package 154" containing eight items, "Trial Rule 77 package 118" containing six items and "Trial Rule 77 package 119" containing two items; on 18 July 2024, "Trial INCRIM package 155" containing three items and "Trial Rule 77 package 120" containing two items ; on 19 July 2024 "Trial INCRIM package 156" containing seven items, "Trial INCRIM package 157" containing one item, and "Trial Rule 77 package 121" containing two items.

4. Trial INCRIM package 149 consists of the French translation of Witness P-2573's witness preparation log.

5. Trial INCRIM package 150 consists of a redacted version of a sketch drawn by Witness P-0664, lesser redacted version of P-1967's statements and annexes thereto, a

lesser redacted version of P-0349's statement, as well as P-1967's witness preparation logs and related annexes.

6. Trial INCRIM package 151 consists of the French translation to annex A of Witness P-1967's witness preparation log.

7. Trial INCRIM package 152 consists of the witness preparation logs and annexes thereto of Witnesses P-0312 and P-0664.

8. Trial INCRIM package 153 consists of the French translation of Witness P-0312's witness preparation log, its annex and a report from the Cyber Unit of the Prosecution related to photographs provided by witness P-0312.
