I. NOTIFICATION

1. The Common Legal Representative of the Former Child Soldiers (the “CLR1”) submits this Communication Report regarding his recent disclosure of evidence.

II. CONFIDENTIALITY

III. DISCLOSURE OF EVIDENCE

3. On 28 August 2024, the CLR1 disclosed to the Prosecutor, the Defence for Mr Alfred YEKATOM, the Defence for Mr Patrice-Édouard NGAÏSSONA and the Common Legal Representatives of Victims of the Other Crimes “V45 Disclosure package 7” containing 26 items together with their respective metadata.¹ The items are listed respectively in Confidential Annex I to this Communication.
