I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as it relates to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. Between 23 and 28 August 2024, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani the following packages. On 23 August 2024, "Trial INCRIM package 158" containing nineteen items and "Trial Rule 77 package 122" containing fourteen items; on 27 August 2024, "Trial INCRIM package 159" containing one item and "Trial Rule 77 package 123" containing four items; on 28 August 2024, "Trial INCRIM package 160" containing one item.

4. Trial INCRIM package 158 consists of P-2161's witness preparation logs and related annexes, as well as lesser redacted versions of the witness statements, screening note and statement acknowledgment of Witnesses P-0834 and P-2232, P-1263's statement and statement acknowledgment by the Witness.

5. Trial INCRIM package 159 consists of the English annex to P-2232's witness preparation log.

6. Trial INCRIM package 160 consists of the French annex to P-2232's witness preparation log.

7. Trial Rule 77 package 122 consists of the identity documents and investigation reports related to Witnesses P-1263, P-0834, P-2161 and P-2232, call data records

related to Witnesses P-0550, P-0922, P-2312 and P-0369 as well as the transcribed statement of Witness P-0446.

8. Trial Rule 77 package 123 consists of the witness preparation log of Witness P-2232, and P-2232's statements taken by the *Mokom* Defence team.
