I. INTRODUCTION

1. Pursuant to Trial Chamber V's ("Chamber") 17 April,¹ and 5 June 2023² decisions on the Prosecution's requests for the formal submission of prior recorded testimonies, the Prosecution annexes addenda supplementing the previously filed³ accompanying declarations of P-0505, P-0567, P-0595, P-1773, and P-2416, completing the requirements set out in Rule 68(2)(b)(iii) of the rules of Procedure and Evidence.

II. CONFIDENTIALITY

2. Pursuant to regulation 23*bis*(1) of the Regulations of the Court ("RoC"), this submission is filed with a "Confidential *EX PARTE*" Annex A, as it concerns witness-related material containing information not available to the other parties to the proceedings. A Confidential Redacted version of Annex A will be filed contemporaneously. Annex B is filed as "Confidential", as it contains witness-related information that may not be made public.

III. SUBMISSIONS

3. The Prosecution files an addendum supplementing the accompanying declarations of P-0505⁴ and P-0567,⁵ effectuated in France (Annex A). The addendum completes the requirements of Rule 68(2)(b)(iii) by confirming that these witnesses (i) made their declarations voluntarily and without undue influence, and (ii) were informed that if the contents of their prior recorded testimony are not true, they may be subject to proceedings for having given false testimony.
