I. Introduction

1. The Registry herewith provides the Presidency with an additional group of documents transmitted by Ms Singla to the Registry on 6 September 2024 following Registry's submission ICC-ROR56-01/24-2.

II. Classification

2. The annex to the present submission is classified confidential pursuant to regulation 23 *bis*(1) of the Regulations of the Court ("RoC") because it contains personal information concerning the Applicant.

III. Procedural History

3. On 29 July 2024, the Registrar issued a decision rejecting Ms Singla's application as she was not considered to meet the requirements to be included in the List of Experts. Therein the Registry specified, in line with regulation 56(2) of the Regulations of the Registry ("RoR"), the procedure on how to apply to the Presidency for review of that decision within 15 calendar days of its notification. It further specified the standard of review before the Presidency.
4. On 14 August 2024, the Registry received *via* email the Applicant's request for review of the Registrar's decision.
5. On 4 September 2024, the Registry notified the "Transmission of 'Demande de réexamen à demande d'inscription sur liste experts'"¹ with two annexes.

6. On the same day the Applicant submitted to the Registry “pour enregistrement en Annexe C, · Les pièces 1 à 10 annexées à la candidature initiale du 18/08/2024, qui n’ont pas été listées dans les Annexes A et B”.²
7. On 6 September 2024, the Registry notified the “Registry Observations on “Demande de réexamen à demande d’inscription sur liste experts” and transmission of additional information”.³
8. On 6 September 2024, Ms Singla addressed an e-mail to the Registry indicating, *inter-alia*, that “Les Annexes A, B,C ne comprennent pas la lettre de demande de révision du 12/08/2024 et ses pièces que vous trouverez pour renvoi ci joint. Pour Annexe D”. Le dossier de révision sera alors complet”.⁴

IV. Applicable law

9. The present submissions are based on regulation 44(1) of the RoC and regulation 56 of the RoR.

V. Submissions

10. The Registry notes that the request for review dated 12 August 2024 was filed by the Registry on 4 September 2024.⁵
11. The Registry notes that the materials received by the Registry prior to 6 September 2024 in support of the request for review dated 12 August 2024 were filed, as received by the Registry, on 4 September 2024.⁶

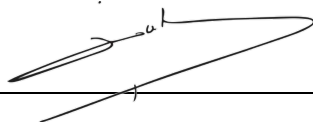
