I. INTRODUCTION

1. The Registry hereby transmits to Pre-Trial Chamber I ("Chamber"), a document, received on 27 September 2024, from the State of Israel, entitled "*Request to re-classify Israel's "Request for Access to the Application for Arrest Warrants for Benjamin Netanyahu and Yoav Gallant", ICC-01/18-187-SECRETExp-AnxI*" (the "Request").

II. PROCEDURAL HISTORY

2. On 27 September 2024, the Registry received an e-mail from the Embassy of Israel, with a document attached thereto entitled "*Request to re-classify Israel's "Request for Access to the Application for Arrest Warrants for Benjamin Netanyahu and Yoav Gallant", ICC-01/18-187-SECRETExp-AnxI*".¹
3. On the same day, the Registry contacted the Chamber to seek guidance as to how to submit the Request.²
4. In Its response, the Chamber instructed the Registry to submit the request *via* a secret Registry's transmission filing ("Instruction").³

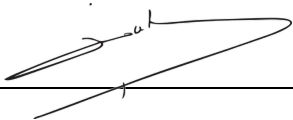
