I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as it relates to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. Between 12 and 30 September 2024, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani the following packages: on 12 September 2024, “Trial INCRIM package 161” containing three items; on 16 September 2024, “Trial INCRIM package 162” containing two items and “Trial Rule 77 package 124” containing three items; on 17 September 2024, “Trial INCRIM package 163” containing two items and “Trial INCRIM package 164” containing one item; on 19 September 2024, “Trial INCRIM package 165” containing one item; on 24 September 2024, “Trial INCRIM package 166” containing ten items and “Trial Rule 77 package 125” containing three items; on 27 September 2024, “Trial INCRIM package 167” containing two items; and on 30 September 2024, “Trial INCRIM package 168” containing ninety-one items and “Trial Rule 77 package 126” containing three items.
