I. INTRODUCTION

1. The Registry hereby transmits to Pre-Trial Chamber I ("Chamber"), a document received on 4 October 2024, from the State of Israel, entitled *"Request for leave to reply to Prosecution Response to Israel's "Abridged Request for an Order Requiring an Article 18(1) Notice, and Staying Proceedings Pending Such a Notice" – ICC-01/18-355-SECRET-Exp-AnxI-Corr"* ("Request").

II. PROCEDURAL HISTORY

2. On 4 October 2024, the Registry received an e-mail from the Embassy of Israel, with a document attached thereto entitled *"Request for leave to reply to Prosecution Response to Israel's "Abridged Request for an Order Requiring an Article 18(1) Notice, and Staying Proceedings Pending Such a Notice" – ICC-01/18-355-SECRET-Exp-AnxI-Corr"*.¹
3. On the same day, the Registry contacted the Chamber to seek guidance on how to submit the Request.²
4. In Its response, the Chamber instructed the Registry to submit the request *via* a secret Registry's transmission filing ("Instruction").³

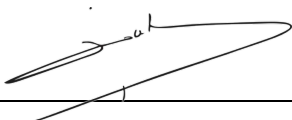
