PRE-TRIAL CHAMBER I (the ‘Chamber’) of the International Criminal Court (the ‘Court’) issues this notification to which it annexes Judge Hohler’s ‘Provision of Information Concerning Previous Employment with the Office of the Prosecutor’.

1. On 22 May 2018, the State of Palestine referred the situation in the State Palestine to the Prosecution pursuant to articles 13(a) and 14 of the Rome Statute, following which the Presidency referred the *Situation in the State of Palestine* to the Chamber.¹
2. On 22 April 2024, the Presidency designated Judge Guillou to replace a judge of the Chamber.²
3. On 25 October 2024, the Presidency designated Judge Hohler to replace a judge of the Chamber.³
4. On 12 November 2024, the State of Israel submitted the ‘Request for Information from Judge Beti Hohler Concerning Prior Activities with the Office of the Prosecutor’,⁴ in which it requests Judge Hohler to provide certain information about her previous employment with the Prosecution.⁵
5. By way of the annexed ‘Provision of Information Concerning Previous Employment with the Office of the Prosecutor’, Judge Hohler provides the relevant information.
