I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as it relates to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. Between 01 October and 31 October 2024, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani the following packages.
