1. On 26 June 2024, Trial Chamber X issued the “Trial Judgment”¹ convicting Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud on eight counts.
2. On 18 September 2024, the Defence filed its “Notice of Appeal against the Trial Judgment”.²
3. On 20 November 2024, Trial Chamber X issued its “Sentencing Judgment”³, imposing a sentence of 10 years on Mr Al Hassan on the basis of the convictions set out in the Trial Judgment.
4. Pursuant to Rule 152(1) of Rules of Procedure and Evidence, the Defence hereby gives notice of discontinuance of its appeal.
