I. INTRODUCTION

1. III. TRANSMISSION

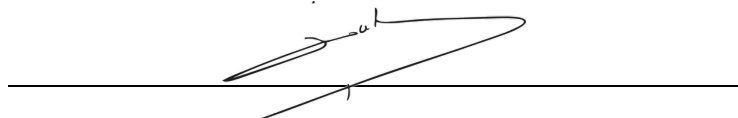
5. Pursuant to rule 13(1) of the Rules of Procedure and Evidence, the Registry hereby transmits, as annex I to this submission, the Request
