I. Introduction

1. The Registry submits the present document and its annex consisting of the E-court protocol pursuant to the *“Decision Setting the Disclosure Regime”*, issued on 12 December 2024, by Pre-Trial Chamber III (“Chamber”).¹

II. Procedural History

2. On 29 October 2024, the Chamber issued its *“Decision on the criteria for holding confirmation of charges proceedings in absentia”*.²
3. On 12 December 2024, the Chamber issued its *“Decision Setting the Disclosure Regime”*,³ in which it ordered the Registry to file the E-court Protocol into the case record.⁴

III. Applicable law

4. For the purpose of the present submission, the Registry has considered *inter alia* regulation 26(4) of the Regulations of the Court and regulation 10(1), (4) and (5) of the Regulations of the Registry.

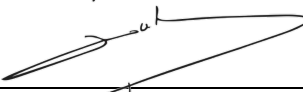
