I. Introduction

1. The Registry hereby submits as annexes one to seven to this filing the list of authorities, filings, evidence, and materials referred to or presented during the closing statements by the parties and participants from 11 to 13 December 2024, pursuant to Trial Chamber I's ("Chamber") oral instruction ("Oral Instruction") dated 11 December 2024.¹

II. Procedural History

2. On 25 September 2024, the Chamber issued the "Order regarding the final briefs and closing statements", whereby it scheduled the closing statements to be held from 11 to 13 December 2024 ("closing statements").²
3. On 5 December 2024, the Chamber directed the parties to provide by way of email a table of authorities, transcripts and any formally submitted evidence to which they would refer during their closing statements ("items").³
4. In support of their closing statements, the parties and participants also presented visual aids ("supporting material").
5. On 11 December 2024, the Chamber issued an Oral Instruction directing the Registry to file the items and supporting material into the case record.⁴
6. In compliance with regulation 29 of the Regulations of the Registry ("RoR"), Hearing not Evidence ("HNE") references were assigned to the items and

supporting material. Upon the request of the Registry,⁵ the parties and participants confirmed the classification levels thereto.

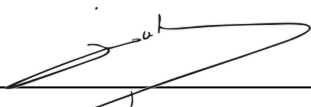
