Pursuant to Pre-Trial Chamber I's order dated 12 February 2025, this document has been reclassified as "Public".

PRE-TRIAL CHAMBER I (the 'Chamber') of the International Criminal Court (the 'Court') renders this decision issuing a corrected version of the 'Warrant of Arrest for Mr Osama Elmasry / Almasri Njeem'.

1. On 18 January 2025, the Chamber, by majority, issued a warrant of arrest against Mr Osama Elmasry / Almasri Njeem (the 'Warrant').¹
2. The Chamber has detected a number of errors in the Warrant and hereby corrects them as follows:
 - At paragraph 13: replacing 'for' with 'of' in line 4;
 - At paragraph 15, replacing 'of' with 'for' after in line 2;
 - At paragraph 19: replacing 'continuous' with 'continue' in line 5;
 - At paragraph 23: replacing 'thousands' with 'thousand' in line 6;
 - At paragraph 24: adding 'of the Statute' in line 7;
 - At paragraph 34: deleting 'any' in line 9 and the 'T' before 'as' in line 11;
 - At paragraph 59: replacing 'abused' with 'abuse' in lines 4 and 5 and adding 'of' in line 5;
 - At paragraph 65: replacing 'victims' with 'victims'' in line 4 and removing 'and' in line 7;
 - At paragraph 72: replacing 'Convention' with 'Convention's' in line 3;
 - At paragraph 76: replacing '[i]n addition' with 'above all' in line 8 and replacing 'an' with 'and' in line 16;
 - At paragraph 88: removing an extra 'that' in line 1 and replacing 'to' with 'of' in line 2;
 - At paragraph 90: removing 'at least' in line 2;
 - At paragraph 92: removing 'for' in lines 6 and 7;
 - At paragraph 93: adding 'shift' in line 1;
 - At paragraph 99: removing 'of' three times in lines 4 and 5; replacing 'article' with 'articles' in line 6; replacing 'the crime against humanity of other inhumane acts (article 7(1)(k) of the Statute)' with 'the war crime and crime against humanity of sexual violence (articles 8(2)(e)(vi) and 7(1)(g) of the Statute); and the war crime and crime against humanity of murder (articles 8(2)(c)(i) and 7(1)(a) of the Statute)'; and replacing '2011' with '2015' in line 10;

- At paragraph 100: adding 'for certain incidents' in line 1; adding 'primarily' in line 2; replacing '(b)' with '(d)' and 'of' with 'for' in line 3; removing 'of' twice in lines 4 and 6; and replacing '2011' with '2015' in line 7;
 - At paragraph 101: replacing '2011' with '2015' in line 4;
 - At page 34: removing 'of' nine times between lines 2 and 11; replacing 'crimes' with 'crime' in line 1; removing 'of the war crime of rape pursuant to article 8(2)(e)(vi) of the Statute' in line 5; removing 'the crime against humanity of other inhumane acts pursuant to article 7(1)(k) of the Statute' in lines 9 and 10; replacing '2011' for '2015' in lines 7 and 15;
3. The Chamber issues a corrected version of the Warrant, including the above adjustments, as a separate annex to the present filing.
4. As indicated in the Warrant,² Judge Flores Liera appends a dissenting opinion. The Chamber includes the dissenting opinion of Judge Flores in the corrected version of the Warrant.

ISSUES a corrected version of the Warrant as an annex to the present decision;

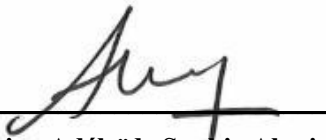
APPENDS the dissenting opinion of Judge Flores Liera to the Warrant;
