I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annexes, appended to this Communication, are classified confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 28 January 2025, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani "Trial INCRIM package 178" containing 56 items. "Trial INCRIM package 178" consists of additional identifying documents and lesser redacted versions of documents related to 20 trial witnesses P-1970, P-2087, P-1277, P-2042, P-1523, P-1825, P-0100, P-2295, P-0966, P-0342, P-0882, P-1427, P-1424, P-1420, P-1297, P-2269, P-3053, P-1313, P-0881 and P-1004.

4. On 28 January 2025, the Prosecution also disclosed "Trial Rule 77 package 136" containing 15 items. "Trial Rule 77 package 136" consists of identifying documents and lesser redacted versions of documents related to six trial witnesses P-2337, P-1427, P-0966, P-2269, P-3112 and P-2295.
