I. INTRODUCTION

4. On 6 February 2025, in its response, the Chamber instructed the Registry to submit the Request *via* a Registry’s transmission filing (“Instruction”).³

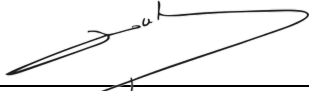
