I. INTRODUCTION

1. The Registry hereby transmits to Pre-Trial Chamber I ("Chamber"), a *"Victim's Request to Submit Observations Concerning a potential finding of noncompliance under article 87(7) against the Republic of Italy, following the release of Osama Elmasry / Almasri NJEEM"* (the "Request") received on 24 February 2025 from Dr. Omer Shatz and Dr. Juan Branco (the "Submitters").
