I. Transmission

1. Pursuant to the Appeals Chamber's "Decision on requests for victims' involvement and access to filings" issued on 21 March 2023,¹ the Registry hereby transmits five representations received from victims in the Situation in the Republic of the Philippines ("Situation") and assessed by the Registry as falling inside the temporal, territorial and material scope of the Situation. The representations contain the views and concerns expressed on behalf of 350 individual victims and 165 families.
