Pursuant to Pre-Trial Chamber I's instruction, dated 12 March 2025, this document is transferred from the situation record ICC-01/12 into the case record ICC-01/21-01/25

THE PRESIDENCY of the International Criminal Court (the 'Court') notes the memorandum of 12 April 2021, annexed hereto, from the Prosecutor pursuant to regulation 45 of the Regulations of the Court (the 'Regulations'), informing that the Prosecutor intends to submit a request to a pre-trial chamber for authorisation to open an investigation into the situation in the Republic of the Philippines, under article 15(3) of the Rome Statute.¹ The Prosecutor further requests that any decision assigning the matter to a pre-trial chamber be filed secret *ex parte*, available only to the Prosecution.

The Presidency recalls regulation 46(2) of the Regulations, pursuant to which the Presidency shall assign a situation to a pre-trial chamber as soon as the Prosecutor has informed the Presidency in accordance with regulation 45 of the Regulations.

The Presidency notes the composition of the Pre-Trial Division as well as the composition of its chambers, including the respective workloads of each Pre-Trial Chamber.² The Presidency further notes the respective assignments, qualifications and experience of the judges.³

Accordingly, the Presidency *hereby decides* to assign, with immediate effect, the situation in the Republic of the Philippines to Pre-Trial Chamber I, with the following composition:

The present decision is issued on a secret basis, at the request of the Prosecutor.

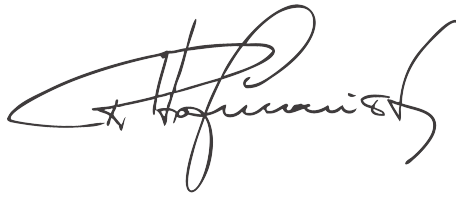
