I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as it relates to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. On 25 and 27 March respectively, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani, the following packages : “Trial INCRIM package 182” containing 4 items and “Trial Rule 77 package 142” containing 15 items; and “Trial Rule 77 package 143” containing 17 items.

4. On 4, 8 and 11 April 2025 respectively, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani, the following packages: “Trial Rule 77 Package 144” containing 35 items, “Trial Other Package 026” containing five items and “Trial Other Package 027” containing two items.

5. Trial INCRIM package 182 consists of documents related to Witnesses P-1432 and P-2087 including one authorisation to disclose information, one witness statement and two translations of witness statements.

6. Trial Rule 77 package 142 consists of documents related to Witness P-1077 including his identity card and his transcribed statements, and one PRF related to Witness P-0349.

7. Trial Rule 77 package 143 consists of one witness statement, and transcripts of hearings in *Yekatom and Ngaissona* of Witnesses P-2012, P-0446 and P-1077.

8. Trial Rule 77 Package 144 consists of two expert reports prepared by P-3112 with respect to *Section de Recherches et d’Investigations* (SRI), Camp de Roux, Colline des

Pantheres, the Presidential Palace and Oubangui River, along with their annexes and translations.

9. Trial Other Package 026 consists of five CDRs related to witness P-2232.

10. Trial Other Package 027 consists of the ICC written statement of Witness P-1994 and its translation.
