I. Introduction

1. The Registry hereby transmits to Pre-Trial Chamber I (“Chamber”), the “Invitation to the Italian Republic to provide submissions concerning its failure to surrender Osama Elmasry/Almasri Njeem to the Court following his arrest. II. Procedural History

2. On 17 February 2025, the Chamber invited the Italian Republic to provide submissions concerning its failure to surrender Mr Njeem to the International Criminal Court.
3. On 14 March 2025, the Registry received a hard copy of Italy’s Submissions from a representative of the Embassy of Italy, at the seat of the Court, at 16.15.
4. On 17 April 2025, the Registry received an additional hard copy document from the Submitter.
