I. INTRODUCTION

1. The Registry hereby transmits to the Pre-Trial Chamber I ("Chamber"), a "Request for authorisation to file submissions" (the "Request"), received on 24 April 2025 from Prof. Morris Kiwinda Mbondenyi, LLD, M.B.S. (the "Submitter").

II. PROCEDURAL HISTORY

2. On 17 April 2025, the Chamber issued its "*Decision on a request for leave to submit amicus curiae observations and setting the procedure regarding requests for authorisation to file submissions*".¹
3. Accordingly, the Chamber instructed the Registry to:²
 - (i) inform any person or entity requesting authorisation to make submissions before the Chamber to do so using the template;
 - (ii) indicate to such a person or entity that for the aforementioned request for authorisation to be transmitted to the Chamber it must not exceed three pages; and
 - (iii) register by way of confidential (unless a more restrictive classification is necessary) transmission filing into the record only those requests that abide by the page limit and the instructions listed in the template ("Instructions").
4. On 24 April 2024, the Registry received an e-mail from Daniel Schmidt on behalf of Prof. Morris Kiwinda Mbondenyi, LLD, M.B.S, with a document attached thereto entitled "*Request for authorisation to file submissions*".³
