I. INTRODUCTION

1. The Registry hereby transmits to Pre-Trial Chamber I ("Chamber"), the Request for authorisation to file submissions submitted by the European Centre for Law & Justice ("Submitter") on 01 May 2025.

2. On 11 April 2025, the Chamber issued its "*Order on reclassification and other procedural matters*", ("Order")¹.
3. On 28 April 2025, the Registry received an e-mail from the Submitter asking to be provided with the template for requesting authorisation to submit amicus curiae observations. As instructed by the Chamber, in its Decision² ("Instructions"), the Registry provided the required template to the Submitter³.
