I. Introduction

1. On 8 May 2025, the assigned Judge Haykel Ben Mahfoudh of the Pre-Trial Division¹ instructed the Registry to redact passages from the transcript of Mr Mahamat Said Abdel Kani's non-privileged call dated 2 February 2025, and ordered the Registry to transmit the redacted transcript to Trial Chamber VI ("Judge's Decision").² The Registry therefore transmits, in Annex, the redacted transcript.

II. Classification

1. Considering regulation 23 *bis*(1) of the Regulations of the Court, the Annex is classified as Confidential *ex parte* only available to Trial Chamber VI in accordance with the Judge's Decision.³
