I. NOTIFICATION

1. The Prosecution submits this communication regarding the disclosure of evidence to the Defence, in compliance with Pre-Trial Chamber I's (the "Chamber") order¹ and pursuant to articles 61(3)(b) and 67(1)(a) and (b) of the Statute, and rules 76(3) and 77 of the Rules of Procedure and Evidence.

2. The Annex to this filing, is classified as "Confidential", as it refers to confidential evidence disclosed *inter partes*.

III. DISCLOSURE OF EVIDENCE

3. On 9 May 2025, as set out in the Prosecution's regulation 35 application filed on the same day,² the Prosecution disclosed to the Defence four items, under an *ad hoc* thematic category:
