I. NOTIFICATION

1. The Prosecution submits this communication regarding the disclosure of evidence to the Defence, in compliance with Pre-Trial Chamber I's (the "Chamber") order¹ and pursuant to articles 61(3)(b) and 67(1)(a) and (b) of the Statute, and rules 76(3) and 77 of the Rules of Procedure and Evidence.

II. CONFIDENTIALITY

2. The Annexes to this filing are classified as "Confidential" as they refer to confidential evidence disclosed *inter partes*.

III. DISCLOSURE OF EVIDENCE

3. On 23 May 2025, the Prosecution disclosed to the Defence 90 items, organised under the following thematic categories:

- a) Pre-Confirmation INCRIM package 009 23 May 2025: Crimes Against Humanity– Murder – Barangay Clearance Operations, Presidential Period (32 items listed in Confidential Annex A);
- b) Pre-Confirmation INCRIM package 010 23 May 2025: Crimes Against Humanity– Murder – Barangay Clearance Operations, Presidential Period (35 items listed in Confidential Annex B); and
- c) Pre-Confirmation Rule 77 package 001 23 May 2025: Contextual Elements – background information – material for the preparation of the Defence (23 items listed in Confidential Annex C).
