The Appeals Chamber of the International Criminal Court,

Having before it the “Yekatom Defence Request for Reclassification” of 25 June 2025 (ICC-01/14-01/18-2775),

Pursuant to regulation 23*bis*(3) of the Regulations of the Court

Issues the following

ORDER

1. The Registrar is directed to reclassify as public the following filings:
 - ICC-01/14-01/18-2772-Conf; and
 - ICC-01/14-01/18-2773-Conf.

REASONS

1. Regulation 23*bis*(3) of the Regulations of the Court provides that a Chamber may reclassify a document when the basis for the classification no longer exists.
2. Following the Appeals Chamber’s order of 19 June 2025,¹ directing *inter alia* the Prosecutor and the Defence for Mr Yekatom to file a public redacted version of their respective filings (ICC-01/14-01/18-2770-Conf and ICC-01/14-01/18-2772-Conf), or seek their reclassification, as appropriate, the Prosecutor filed a public redacted version of filing ICC-01/14-01/18-2770-Conf,² and the Defence requested reclassification as public of filing ICC-01/14-01/18-2772-Conf.³
3. The Appeals Chamber finds that no reason exists for ICC-01/14-01/18-2772-Conf and ICC-01/14-01/18-2773-Conf to remain confidential and directs that these documents be reclassified as public.
