The Applicant

I. Introduction

1. The Registry hereby transmits to the Presidency, the application for review of the decision of the Registrar issued on 17 July 2025 (“Registrar’s Decision”), denying inclusion of an applicant in the List of Experts (“Applicant”), pursuant to regulation 56 of the Regulations of the Registry (“RoR”), received *via* email on 27 July 2025 (“Application for Review”).¹

II. Classification

2. The annexes to the present submission are classified as confidential pursuant to regulation 23 *bis*(1) of the Regulations of the Court (“RoC”) because they contain personal information concerning the Applicant.

III. Procedural History

3. On 16 June 2025, the Registry received the Applicant’s application dated 4 June 2025, together with supporting documents for inclusion in the List of Experts.²
4. On 4 July 2025, the Registry submitted the application to the Registry’s Independent Expert responsible for assessing the qualifications of applicants to the List of Experts.³
5. On 8 July 2025, the Registry received the Independent Expert’s assessment results of the Applicant.⁴ The Independent Expert considered, *inter alia*, that the Applicant’s “[f]ields of expertise and the related legal disputes did not fall within

the mandate of the ICC".⁵ Consequently, the Independent Expert recommended that the application not be retained.

6. On 17 July 2025, the Registrar issued the Decision denying the Applicant's inclusion in the List of Experts. The Registrar notified the Applicant of his Decision stating the reasons for the refusal pursuant to regulation 56(2) of the RoR and informing the latter of the 15-day deadline to request for judicial review of the Registrar's Decision before the Presidency.⁶
7. On the same day, the Registry received an email from the Applicant, in which he expressed confusion as to the Registrar's Decision.⁷
8. On 22 July 2025, the Registry replied to the Applicant, providing further information regarding the possibility of requesting a judicial review of the Registrar's Decision by the Presidency.⁸
9. On 27 July 2025, the Registry received the Application for Review, which was submitted as an attached letter *via* email.⁹

IV. Applicable law

10. The present submission is based on regulation 44(1) of the RoC and regulation 56 of the RoR.
