Issues the following

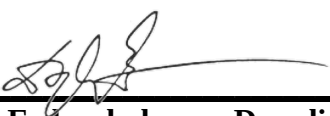
ORDER

The Registrar is directed to reclassify as public documents:
ICC-01/11-191-US-Exp; ICC-01/11-196-US-Exp; and
ICC-01/11-199-US-Exp.

REASONS

1. Regulation 23*bis*(3) of the Regulations of the Court provides that a Chamber may reclassify a document when the basis for the classification no longer exists.
2. Noting the Prosecutor’s submission concerning reclassification as public of documents ICC-01/11-191-US-Exp and ICC-01/11-199-US-Exp the Appeals Chamber directs that these documents including ICC-01/11-196-US-Exp be reclassified as public.
