I. INTRODUCTION

1. The Registry hereby transmits to the Appeals Chamber (“Chamber”), a “Request for Targeted Transparency Measures to Safeguard Judicial Integrity Following the Appeals Chamber’s Decision of 1 August 2025 (ICC-02/18-118)” (“Request”) received on 12 August 2025, from Mr Robert Carmona-Borjas and the Arcadia Foundation.

II. PROCEDURAL HISTORY

2. On 12 August 2025, the Registry received an e-mail from Mr Robert Carmona-Borjas and the Arcadia Foundation, with one document attached consisting of the Request¹.
3. That same day, the Registry consulted with the Chamber to obtain guidance on the appropriate procedure for submitting the Request and its annex into the case record.²
