I. Introduction

1. This report is submitted in the context of the implementation of the "Order inviting observations pursuant to rule 119(3) of the Rules of Procedure and Evidence and regulation 51 of the Regulations of the Court" ("Order") issued by Pre-Trial Chamber I ("Chamber") on 18 June 2025.¹

II. Procedural history

2. On 12 March 2025, pursuant to a warrant of arrest issued by the Chamber on 7 March 2025,² Mr Rodrigo Roa Duterte ("Mr Duterte") was surrendered to the Court.
3. On 12 June 2025, the Defence of Mr Duterte filed the "Urgent Request for Interim Release",³ ("Interim Release Request") requesting interim release to [REDACTED] in accordance with article 60(2) of the Rome Statute ("Statute").
4. On 16 June 2025, the Defence filed the "Defence Request for Observations from the Host State",⁴ requesting the Chamber to seek observations from the Kingdom of the Netherlands ("host State" or "the Netherlands").
5. On 18 June 2025, the Chamber issued its Order inviting [REDACTED] and the Netherlands to submit any observations that they consider relevant to the

Chamber's adjudication of the Interim Release Request by no later than 2 July 2025.⁵

6. On 3 July 2025, the Registry submitted its "First Registry's Report on consultations with States pursuant to the Chamber's Order", in which it transmitted: i) the observations from the [REDACTED] authorities and; ii) a communication from the Dutch authorities [REDACTED].⁶

Pursuant to regulation 23bis(2) of the Regulations of the Court ("RoC"), this report and its annexes are classified confidential because they refer to a document registered with the same classification level and as they refer to information related to communications from State authorities containing sensitive information.

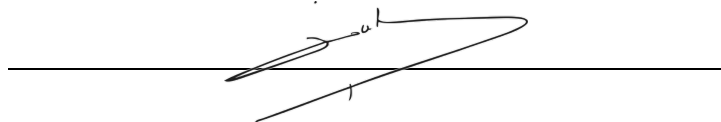
V. Submissions
